1. The Democratic Socialist Republic of Sri Lanka received for a loan from the Asian Development Bank (ADB) towards the cost of the Railway Efficiency Improvement Project (REIP). A portion of this loan will be applied for eligible payments under the contract named above.
2. The Ministry of Transport & Highways /Sri Lanka Railways ("the Employer") now invites sealed bids from eligible bidders for the following contract package.

3. The National Competitive Bidding will be conducted in accordance with ADB's Single Stage One Envelope Bidding Procedure.
4. Eligible bidders must meet the following criteria:
  - (i) Pending Litigation shall not represent more than 50% of the bidder's net worth.
  - (ii) The bidders' last year's net worth shall be positive.
  - (iii) Average annual construction turnover (AACT) within last 5 years, financial resources, similar construction experience within last 05 years & construction experience in key activities as given in the table below.
